AMARJOT BHATTI, J.

Petitioner-Fakruddin has filed the present petition under Section 482 Bharatiya Nagarik Suraksha Sanhita, 2023, for grant of anticipatory bail in FIR No.318, dated 01.09.2024, under Sections 61 of BNS, 2023 Section 13(2) of the Haryana Gauvansh Sanrakshan and Gausamvardhan Act 2015, Section 11 of Prevention of Cruelty to Animals Act, 1960, registered at Police Station Ferozepur Zhirka, District Nuh (Haryana).

2. As per facts of the case, on 01.09.2024 SI Sunit along with police party received information from reliable source that Alam, Zakir along with 3/4 companions indulged in illegal cow slaughtering. They were loading cows in a pick up vehicle and they were coming towards Rajashtan via village Biban route. In case, a Naka is organized, they could be apprehended. On the basis of this information, barricades were placed on the road and after about 15-20 minutes, two pick-up vehicles were seen

coming from the side of Mundaka. Said vehicles were apprehended. Driver

of pick up No. RJ32-GB-9003 disclosed his name as Zakir whereas person sitting on the conductor’s side disclosed his name as Ramu from which three cows were recovered. On checking of second vehicle bearing registration No.RJ32-GB-5663, the person sitting on driver’s seat disclosed his name as Zakir and two persons were seat sitting on conductor’s side namely Vijay and Alam. Upon checking of vehicles, five cattles were recovered. On the basis of this recovery, present FIR has been registered.

3. As per order dated 04.10.2024, arrest of present petitioner was stayed subject to the joining of investigation. Status report has been received, according to which present petitioner joined investigation on 09.10.2024 and he is not required for any other purpose. As per the facts, present petitioner is named in disclosure statement being registered owner of vehicle No. RJ32-GB-9003.

3. In the light of aforesaid factual position, anticipatory bail petition filed by petitioner – Fakruddin is allowed. He be not arrested. In case of his arrest, he be released on bail to the satisfaction of Arresting/ Investigating Officer concerned, subject to condition that petitioner will join the investigation as and when required. He will not tamper with or interfere with investigation and will not leave country without prior permission as provided under Section 482(2) BNSS.

4. Pending miscellaneous application(s), if any, stand disposed of accordingly as well.
