KULDEEP TIWARI, J.(Oral)

1. On 01.10.2024, this Court had passed the hereinafter extracted order, upon the instant petition:-

“1. Through the instant petition, as instituted under Section 482 of the B.N.S.S., 2023, the petitioner seeks the concession of anticipatory bail, in case FIR No.135 dated 14.08.2024, under Sections 118(1)/126(2)/351(3) of the B.N.S., 2023, registered at P.S. Chheharta, District Police Commissionerate Amritsar.

2. The learned counsel for the petitioner inter alia submits that, although specific injury(ies) has been attributed to the petitioner that, he gave ‘datar’ blow on the complainant’s head, however, the medical record makes it apparent that the injury(ies) suffered by the complainant have been declared “simple in nature”. He also submits that, vide order dated 19.09.2024, drawn upon CRM-M-46621-2024, the petitioner’s coaccused Gurshan Singh @ Gurshan Maan and Amandeep Singh @ Vicky have already been granted the relief of interim bail by this Court.

3. Notice of motion for 23.10.2024.

4. Mr. Raghav Garg, A.A.G, Punjab, accepts notice on behalf of respondent-State of Punjab.

5. In the meantime, the petitioner is directed to join the investigation and to appear before the investigating agency, as and when called upon to do so. In the event of his arrest, he shall be admitted to interim bail on his furnishing bail bonds to the satisfaction of the Arresting/Investigating Officer. The petitioner shall abide by the terms and conditions as envisaged under Section 482(2) of the B.N.S.S., 2023.

6. To be heard with CRM-M-46621-2024. ”

2. Today, the learned State counsel has, on instructions imparted to him by ASI Sukhdev Singh, stated that pursuant to the making of the hereinabove extracted order, the petitioner(s) had joined investigation and he is no longer required for custodial interrogation.

3. In view of the above, the hereinabove extracted interim order dated 01.10.2024, is hereby made **absolute**, subject to the hereinafter extracted conditions:-

“(i) the petitioner(s) shall not commit an offence similar to the present offence;

(ii) the petitioner(s) shall not directly or indirectly make any inducement, threat or promise to any person acquainted with the facts of the case;

(iii) the petitioner(s) shall make himself/herself available for interrogation by a police officer as and when required.”

4. This order should not be treated as “blanket” order. It will not be read granting petitioner(s) indefinite protection from arrest. It shall be confined to the FIR mentioned *ibid* and will not operate in respect of any other incident that involves commission of an offence.

5. Needless to say that anything observed hereinabove shall not be construed to be an opinion on the merits of the case.

6. All pending application(s), if any, also stand **disposed** of accordingly.
