Mr. Yugank Goyal, Advocate, accepts notice on behalf of
respondent Nos.1 to 3/non-applicants.

Learned counsel for the respondent Nos.1 to 3 submits
that he has no objection if the date of hearing of the main case is
preponed and the matter being taken up today itself for disposal. He
further submits that as per the compromise dated 23.05.2024, the
same is subject to the appellant withdrawing the present appeal, as
stipulated in clause-1 thereof.

In view of the above and no objection raised by counsel
opposite, the application (CM-6086-C-2024) for preponement of the
date of hearing of the Regular Second Appeal is allowed, the hearing



is advanced from 23.08.2024 to today and with the consent of the parties, same is taken on board.

Application (CM-6087-C-2024) for placing on record original copy of compromise dated 23.05.2024 (Annexure A-1) is allowed. Annexure A-1 is taken on record subject to all just exceptions.

Application (CM-6088-C-2024) under Order 23 Rule 3 CPC read with Section 151 CPC, is for disposal of the main appeal, in view of the compromise dated 23.05.2024 (Annexure A-1).

Learned counsel for the appellant submits that parties have amicably settled their *inter se* dispute and have effected compromise dated 23.05.2024 (Annexure A-1), which has been reduced into writing and in view of the said compromise, learned counsel for the appellant seeks withdrawal of the present Regular Second Appeal.

Learned counsel for the respondent Nos.1 to 3 affirms the aforesaid submission and raises no objection to the limited prayer made for withdrawal of the main appeal in the light of the aforesaid compromise effected between the contesting parties.

CMs stand disposed of.
