1. Instant writ petition has been filed by the petitioner under Articles 226/227 of the Constitution of India for issuance of directions to respondent No.1 to stop the recovery @ 60% per month from the salary of the petitioner till the pendency of the statutory appeal dated 19.10.2024 (Annexure P-5) filed by the petitioner against the orders of punishment dated 08.10.2024 (Annexure P-3) issued under endorsement No.EST-SBS Nagar (54)-2024/3434 dated 16.10.2024 and dated 08.10.2024 (Annexure P-4) issued under endorsement No. EST-SBS Nagar (54)-2024/3435 dated 16.10.2024 passed by respondent No.1, whereby recovery of Rs.6,26,754/- and Rs.5,35,444/-, respectively has been imposed upon the petitioner. In the alternative



prayer has been made to stay the operation of the orders dated 08.10.2024 (Annexures P-3 and P-4) till respondent No.2 – appellate authority decides the statutory appeal dated 19.10.2024 (Annexure P-5) filed by the petitioner.

2. Learned counsel for the petitioner submits that against the impugned punishment orders dated 08.10.2024, petitioner has preferred appeal dated 19.10.2024 (Annexure P-5) and petitioner would be satisfied if time-bound directions are issued to the Appellate Authority to consider and decide the said appeal and till decision of the said appeal, no recovery may be effected from the petitioner.

3. Notice of motion.

4. Mr. Varinder Singh Saini, Advocate, accepts notice on behalf of the respondents and has no objection if the time-bound directions are issued to the Appellate Authority to consider and decide the appeal filed by the petitioner.

5. I have heard learned counsel for the parties and have gone through the case file.

6. Respondent No.2-Appellate Authority is directed to decide the appeal dated 19.10.2024 (Annexure P-5) filed by the petitioner, in accordance with law by passing a speaking order as expeditiously as possible preferably within a period of six months from the date of receipt of certified copy of this order. Since the statutory appeal filed by the petitioner is pending and yet to be decided, it will be in the interest of justice that no further recovery be effected from the
