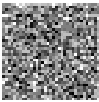

DEEPAK MANCHANDA J. (ORAL)

Present petition has been filed under Article 226 of the Constitution of India for issuance of directions to respondents No. 1 to 3 for providing protection of life and liberty and security to petitioners who are in a live-in-relationship and not to harass or interfere in the peaceful life of the petitioners at the behest of respondents No.4 to 6 and their family members.

Learned counsel for the petitioners contends that both the petitioners with their free will are staying in a live-in relationship and have also decided to get married after attaining the marriageable age as the date of birth of the petitioner No.1 is 01.01.2001 and petitioner No.2 is 20.05.2004. Learned counsel for the petitioners further contends that petitioners have submitted a representation dated 23.10.2024 (Annexures P-3) to respondent No. 2-Senior Superintendent of Police, District Pathankot mentioning the



grievance raised herein, however the same has not been decided till date. It is further contended by learned counsel for the petitioners that petitioners would be satisfied if the representation dated 23.10.2024 (Annexure P-3) is decided by the respondent No.2-Senior Superintendent of Police, District Pathankot.

Notice of motion restricted to respondent Nos. 1 to 3, only.

Mr. Rahul Jindal, AAG, Punjab, who is present in the Court, accepts notice on behalf of respondents No. 1 to 3 and has no objection if the present petition is disposed of directing the respondent No. 2-Senior Superintendent of Police, District Pathankot to decide the representation dated 23.10.2024 (Annexure P-3) in accordance with law.

In view of the above, the present petition is disposed of with a direction to respondent No. 2-Senior Superintendent of Police, District Pathankot to decide the representation dated 23.10.2024 (Annexures P-3) of the petitioners after taking into consideration all the relevant aspects, within a period of four weeks from the date of receipt of a certified copy of this order, in accordance with law.

The Registry is directed to send a copy of this order along with copy of the petition to respondent No.2-Senior Superintendent of Police, District Pathankot for requisite compliance.
