Both these writ petitions being inter-related, the Registry  
was directed by this Court vide order dated 18.11.2024 to tag the file of  
CWP-21367-2024 with the present petition.

Counsel for the petitioner contends that he has already paid  
the challan value as demanded by the respondents and has instructions

to withdraw the said writ petition.

Counsel for the respondent-State has no objection to the same.

Registry is accordingly directed to list the CWP-21367-2024 for today and to show the same in its supplementary list as well.

The said writ petition is ordered to be disposed of as withdrawn.

It is further argued that insofar as CWP-30987-2024 is concerned, the petitioner approached this Court challenging the letter No. 1095 dated 20.09.2024 issued by respondent No.6, whereby the application dated 12.08.2024 for issuance of 'No Objection Certificate' to transfer the ownership of petitioner's vehicle bearing Registration No. HR-74B-1238 in the name of one Kasim has been rejected on account of pendency of CWP-21367-2024.

Learned Counsel contends that since he has withdrawn the aforesaid CWP-21367-2024 and the amount as demanded, on account of challan already stands paid, there would be no impediment to respondent No.6-Regional Transport Authority, Nuh to issue the 'No Objection Certificate' for transferring the vehicle bearing registration No. HR-74B-1238.

Learned State Counsel contends that they would have no objection to the petition being disposed of at this juncture with an appropriate direction to the Regional Transport Authority, Nuh.

The present writ petition CWP-30987-2024 is accordingly disposed of with the consent of the parties and without going into the merits of the present case by setting aside the communication dated

20.09.2024 declining to grant 'No Objection Certificate' on account of pendency of CWP-21367-2024.

In view of the withdrawal of the aforesaid writ petition by the petitioner, the Regional Transport Authority, Nuh is directed to take a fresh decision on the application of the petitioner seeking transfer of vehicle bearing registration No. HR-74B-1238 in favour of the subsequent purchaser i.e. Kasim.

Let an appropriate decision be taken by the respondent within a period of two months of receipt of certified copy of this order.
