1. This petition has been filed under Section 482 of the Code of Criminal Procedure, 1973 seeking quashing of FIR No.106 dated 24.07.2021 under Sections 406 & 498-A of the Indian Penal Code, 1860, registered at Police Station City Morinda, Tehsil and District Rupnagar (Annexure P-1) along with all subsequent proceedings arising therefrom on the basis of compromise dated 23.10.2024 (Annexure P-2).

2. *Vakalatnama* on behalf of respondent No.2 has been filed and the same is taken on record. Registry is directed to tag the same at the appropriate place.

3. The following order was passed on 22.11.2024 :-

*"This petition has been filed under Section 482 of the Code of Criminal Procedure, 1973 seeking quashing of FIR No.106 dated 24.07.2021 under Sections 406 & 498-A of the Indian Penal Code, 1860, registered at Police Station City Morinda, Tehsil and District Rupnagar (Annexure P-1) along with all subsequent proceedings arising therefrom on the basis of compromise dated 23.10.2024 (Annexure P-2).*



*Learned counsel for the petitioners submits that presently, petitioner No.1 is residing abroad, therefore, his statement with regard to compromise (Annexure P-2) may be recorded through his Special Power of Attorney holder i.e. his father.*

*Notice of motion.*

*At this stage, on asking of the Court, Mr. Sandeep Kumar, DAG, Punjab accepts notice on behalf of respondent No.1-State and Mr. Jasinder Singh Sekhon, Advocate accepts notice for respondent No.2 and files Memorandum of Appearance, which is taken on record. He undertakes to file his Vakalatnama in the Registry on or before the date fixed. Copy of the paper book be supplied to them during course of the day.*

*Service is complete.*

*Adjourned to 16.12.2024.*

*In the meanwhile, the parties are directed to appear before learned trial Court/Illaq Magistrate within two weeks from today or any other date convenient to learned trial Court/Illaq Magistrate, to get their statements recorded regarding compromise and after recording their statements, learned trial Court/Illaq Magistrate is directed to send report regarding the genuineness of compromise and also to intimate whether any PO proceedings are pending against any of the party on or before the date fixed.*

*As prayed for, learned trial Court/Illaq Magistrate is directed to record statement of petitioner No.1, in terms of the compromise (Annexure P-2), through his father-Special Power of Attorney.*

*A copy of this order be sent to learned trial Court/Illaq Magistrate through fax for compliance.”*

4. In compliance of the aforesaid order, a report has been received from the concerned jurisdictional Court that the compromise between the parties is genuine and arrived at without any pressure or coercion from anyone.

5. In view of the compromise and the ratio of law laid down by the Hon'ble Supreme Court in ***Narinder Singh and others vs. State of Punjab and another, (2014) 6 SCC 466, Ramgopal and another Vs. State of Madhya Pradesh 2021 SCC OnLine SC 834*** and ***Shakuntala Sawhney (Mrs) Vs.***



*Kaushalya (Mrs.) and others (1980) 1 SCC 63* and Full Bench of this Court in *Kulwinder Singh Vs. State of Punjab 2007 (3) RCR (Crl.) 1052*, this petition is allowed and FIR No.106 dated 24.07.2021 under Sections 406 & 498-A of the Indian Penal Code, 1860, registered at Police Station City Morinda, Tehsil and District Rupnagar (Annexure P-1) and all consequential proceedings arising out of the same are quashed, qua the petitioners.
