- The petitioner, who has been summoned under Section 319 Cr.P.C to face trial in a case FIR No.,176 dated 22.07.2021, under Sections 302, 120-B IPC and Under Section 25 of Arms Act, 1959, registered at Police Station Pillu Khera, District Jind, as an additional accused, filed the instant petition for grant of pre arrest bail.

- On 14.12.2023, the following order was passed:-

“ *Instant petition has been filed under Section 438, Cr.P.C., for grant of anticipatory bail in:-*

Counsel for the petitioner submits that four persons were named as an accused in the FIR viz. Ravinder, present petitioner, Jagphool, Satbir as well as Rahul and after investigation, petitioner and Jagphool were found to be innocent. He submits that both of them have now been summoned as additional accused by learned Additional Sessions Judge, Jind vide order dated 26.10.2023, Annexure P5 on an application filed under Section 319 Cr.P.C. Counsel submits that the petitioner is prepared to surrender before the trial Court and join the proceedings.

Notice of motion.

On asking of the Court, Mr. Munish Sharma, DAG, Haryana, accept notice on behalf of the respondent - State.

Let the petitioner surrender before the trial Court and join t proceedings on or before 20.12.2023. On doing so, he shall be released on inter bail on furnishing bail/surety bonds to the satisfaction of the Court concerned.

3. Counsel for the petitioner submits that in compliance of the directions of this Court, the petitioner has caused his appearance before the learned trial Court concerned and he has been released on interim regular bail by the learned trial Court concerned. He further submits that the petitioner is ready and willing to face the trial, and will cause appearance on each and every date as fixed by the learned Court concerned.
4. Learned State counsel, on instruction imparted by ASI Rajesh, informs this Court that the petitioner has complied with the direction of this Court and has caused appearance before the learned trial Court concerned.
5. In view of the above, the order dated 14.12.2023, is hereby, made absolute subject to the condition that the petitioner would keep on appearing before the learned trial Court concerned to face the trial.
