1. Prayer in the present petition is for quashing of the order dated 15.07.2024 (Annexure P-3) vide which bail of the petitioner was cancelled and his bail/surety bonds were forfeited to the State and he was ordered to be summoned through non-bailable warrants in a complaint case No.NACT-233-2022 titled as Arshdeep Singh vs. Gurmeet Singh.

2. It has been contended by learned counsel for the petitioner that the petitioner has been falsely implicated in the present case. He submits that the petitioner was granted bail by learned trial Court and thereafter, he was regularly appearing before it. He submits that the petitioner was suffering from depression and due to which he could not appear before the trial Court on 15.07.2024 and his bail was cancelled and bail/surety bonds were forfeited to the State and he was ordered to be summoned through warrants of arrest. He submits that absence of the petitioner was totally unintentional and due to the circumstances beyond his control. He further submits that the petitioner is ready to appear before the trial Court and abide by all the terms and condition, if any imposed by this Court.

3. Notice of motion.

4. Mr. Tarun Aggarwal, Sr. DAG, Punjab, accepts notice on behalf of the State and has opposed the submissions made by counsel for the petitioner. He has further submitted that the learned trial Court has rightly cancelled the bail of the petitioner as on the date of hearing he had failed to appear before it.

5. Heard.

6. After hearing learned counsel for the parties and perusing the record, it is evident that due to alleged health condition of the petitioner, he failed to appear before the trial Court on 15.07.2024 and on account of which his bail was cancelled and bail bonds/surety bonds were forfeited to the State and he was ordered to be summoned through non-bailable warrants. In these circumstances, when the petitioner is ready to join the trial and face the proceedings, the order dated 15.07.2024 is set aside subject to payment of Rs.10,000/- as cost to be paid by the petitioner to the complainant within a period of 10 days from today.

7. The petitioner is directed to appear before the trial Court within a period of ten days from today and file an appropriate application alongwith costs of Rs.10,000/- and the trial Court would grant him bail till the disposal of the case on his furnishing fresh bail/surety bonds to its satisfaction. The petitioner will have protection from arrest for a period of ten days from today. Costs of Rs.10,000/- shall be paid to the complainant forthwith on his appearance before the trial Court. The trial Court is free to impose any condition on the petitioner while admitting him to bail.

8. Needless to say that in case the petitioner fails to comply with

the abovesaid direction, this order would be of no avail to him and the order dated 15.07.2024 will come in force and the present petition shall be deemed to have been dismissed.

9. Petition stands disposed of in abovesaid terms.
