The instant petition has been instituted under Articles 226/227 of the Constitution of India, 1950 seeking issuance of a writ in the nature of Mandamus directing the respondents to pay the outstanding dues to the amount of Rs. 1,02,39,528/- alongwith 18% per annum qua the works executed by the petitioner.

Learned counsel for the petitioner submits that with regard to his grievance, he has served Legal Notice dated 05.08.2024 (Annexure P-5) to the respondent-authorities but no action has been taken by them.

Mr. Vivek Saini, Advocate appears and accepts notice on behalf of respondents No.1 to 4-UHBVNL.

Learned counsel for the petitioner, however, submits that at this juncture, he would be satisfied if respondent No.4-the Executive Engineer, Sub Urban Division, UHBVNL, Sonipat is directed to consider and decide the Legal Notice dated 05.08.2024 (Annexure P-5) in a time bound manner.

Learned Counsel appearing on behalf of respondents No.1 to 4-UHBVNL does not oppose the prayer made by learned counsel for the petitioner.

Accordingly, in view of the above, with the consent of the parties and without commenting anything on the merits of the case, the present petition is disposed of while directing respondent No.4-the Executive Engineer, Sub Urban Division, UHBVNL, Sonipat to consider and decide the Legal Notice dated 05.08.2024 (Annexure P-5) by passing a reasoned and speaking order after affording an opportunity of hearing to the respective parties within a period of three months from the date of receipt of certified copy of this order.

Needless to mention that upon considering the said Legal Notice, if any amount is found due and payable to the petitioner, the same shall be disbursed in his favour within a further period of three months.

In the event of non-payment of dues within the abovesaid period, the same shall be released along with interest @ 6% per annum from the date of filing of present petition to be paid to the petitioner and further subject to additional payment of costs of Rs.50,000/- to be deposited with the

Poor Patient Welfare Fund (PPWF) of Post Graduate Institute of Medical Education & Research, Chandigarh. The said additional financial liability of accrued interest and costs shall be subject to recovery from the erring official.

Petition stands disposed of accordingly.
