I.A. 39760/2024 (u/S 151 of CPC, 1908)

1. The present Application has been taken up on mentioning by the learned counsel for the Applicant-Plaintiff.
2. By way of present Application, the Applicant-Plaintiff seeks modification of the Judgment dated 30.08.2024.
3. It is submitted in the application that the name of the learned Senior Advocate i.e., Mr. Rajeeve Mehra, who addressed the final arguments on behalf of the Applicant-Plaintiff, has not been inadvertently recorded in the memo of appearance of the Judgment dated 30.08.2024. Therefore, the request is made that the Judgment dated 30.08.2024 may be modified to the extent that the name of the learned Senior Advocate Mr. Rajeeve Mehra may be recorded in the memo of appearance.
4. Learned counsel appearing on behalf of the defendant Nos. 1 and 2 also submits that the name of the learned Senior Advocate i.e., Mr. Davinder Singh, who addressed the final arguments on behalf of the defendant Nos. 1



and 2, has not been inadvertently recorded in the memo of appearance of the Judgment dated 30.08.2024.
