1. By way of present petitions filed under Section 482 Cr.P.C., the petitioners impugn the order dated 09.04.2024 vide which the NBWs have been issued against them.
2. Learned counsel for the petitioners submits that an application for exemption from personal appearance was filed, however, the same was dismissed on the ground that the petitioners had previously not appeared before the trial court. He further submits that the petitioners have also preferred the petitions being CRL.M.C. 5687/2023, CRL.M.C. 5806/2023 and CRL.M.C. 3193/2024 in which notices have been issued and are now listed on 09.05.2024.
3. Learned counsel for the petitioners, on instructions, submits that the petitioners undertake to appear before the trial court on the next date of hearing which is 02.05.2024. The statement made on behalf of the petitioners



is accepted and taken on record. They are made bound by the same.

4. Subject to the petitioners appearing before the trial court on 02.05.2024, the NBWs issued against them are set aside.

5. In view of the above, the petitions are disposed of alongwith the pending applications.
