1. These applications have been filed on behalf of the Respondent seeking addition of names of Advocates for the Respondent in the Order



dated 14.05.2024 and correction of names of Advocates appearing for the Respondent in the Order dated 17.05.2024.

2. It is stated by the learned Counsel for the Respondent that in the Order dated 17.05.2024, the appearance of Advocates Ms. Roopali Chaturvedi and Ms. Akansha Srivastava has not been recorded and instead the names of some other Advocates, namely, Mr. Sumer Dev Seth and Ms. Riya Kumar has been recorded.
