1. The present petition has been filed alleging non-compliance of the order dated 09th February, 2022 passed in W.P.(C) No. 13478/2021 and W.P.(C) No. 13306/2021.
2. The operative portion of the aforesaid order reads as under:

“xxx xxx xxx

4. I am therefore of the view that the impugned decision, having been taken without following the principles of natural justice, cannot be sustained and are, therefore, set aside. The matters are remanded back to the respondent for reconsideration of the petitioners' applications by granting



an opportunity to the petitioners to cure the deficiencies, if any, found in the inspection report. The said decision would be taken within 8 weeks from today.

3. This Court notes that a compliance affidavit has been filed on behalf of the respondent, wherein it is stated that by letter dated 17th August, 2022 issued by the Ministry of Skill Development and Entrepreneurship, Directorate General of Training, Government of India, the competent authority has recommended affiliation of the trades/units of the petitioner i.e. B G Sharma ITI College Private Industrial Training Institute, with National Council for Vocational Training (“NCVT”). The letter dated 17th August, 2022 issued by the respondent reads as under:
