W.P.(CRL) 2132/2024**

2. This application under Section 528 of the Bharatiya Nagarika Suraksha Sanhita, 2023 has been filed by the learned Amicus Curiae, inter alia, seeking corrections in the judgment dated 8th November, 2024.

3. Learned *Amicus* has pointed out that some typographical errors have occurred in the said judgment in paragraph 21 at serial No. 4, paragraph 33, paragraph 41 at serial No. (2) and paragraph 43(xii) and the same are required



to be corrected.

4. The relevant portions of the aforesaid paragraphs after rectification shall read thus: -

“21.

33. The amount received by Mr. Tola Kant Pandey and his family is to the tune of approximately Rs.18,20,89,000/-, even as per the report of the Id. Amicus Curiae. According to Mr. Tola Kant Pandey, the same was gifted to him and his family members by Dr. Rattan. The amount, which has been transferred to Mr. Satish Kumar, is to the tune of approximately Rs.95 lacs, and to Mr. Vishal Sood is to the tune of approximately Rs.16,67,97,627/-.

(xii) Insofar as the Committee is concerned, the fee of the Supervising Guardian- Mr. Akshay Makhija, Senior Advocate is fixed for Rs. 2 lakhs per month and Rs.1 lakh for the **Certified Managerial Accountant**- Mr. Lalit Grover, **Certified Managerial Accountant**, which shall be paid from the running accounts of Dr. Rattan. If the Guardianship Committee needs to bear any expenses, the same shall be borne from the accounts



of Dr. Rattan.”

5. Let the above corrections be made in the judgment dated 8th November, 2024 and the corrected judgment be uploaded afresh along with today's order as corrigendum.
6. The application is disposed of in the above terms.
