1. By way of present application, the applicant/petitioner seeks modification/deletion of condition no.(i) contained in order dated 19.11.2024 vide which he was admitted to regular bail.
2. Learned counsel for the applicant submits that the applicant is a resident of Dehradun, Uttarakhand and often requires to visit his native place.
3. Issue notice.
4. Notice is accepted by learned APP for State who states upon instructions that he has no objection to the prayer made provided that the applicant continues to remain available during the trial. Learned counsel for the applicant submits that the applicant undertakes to remain present before the learned Trial Court on each and every date fixed before it and that he



will also remain available during further investigation, unless specifically exempted.

5. In view of the aforesaid, the application is allowed and the condition no.(i) contained in the order dated 19.11.2024 is deleted.

6. The application is disposed of in above terms.
