1. With consent of the parties, paragraph 12 of the impugned order dated 23rd July 2024 is set aside. However, M/s. Orris Infrastructure Private Limited is given liberty to raise all contentions and submissions *qua* the show-cause notice dated 10th July 2024 either before the Investigating Officer or by filing appropriate remedies in accordance with law.
