1. The petitioner has filed the present petition, *inter alia*, impugning the notice dated 30.08.2024 (hereafter *the impugned notice*) issued under Section 148 of the Income Tax Act, 1961 (hereafter *the Act*) for the initiation of re-assessment proceedings in respect of the assessment year 2016-17.
2. It is the petitioner's case that impugned notice has been issued beyond the prescribed period. The said issue is covered in favour of the assessee by the decision of this Court in ***Manju Somani v. Income Tax Officer Ward-70(1) & Ors : Neutral Citation : 2024:DHC:5411-DB.***
3. The petition is, accordingly, allowed and the impugned notice is set aside.



4. The petition is disposed of in the aforesaid terms. Pending applications also stand disposed of.
