(i) FDR No. 62200300003827 dated 1 December 2022 for ₹ 5 lakhs deposited in the Bank of Baroda, G-25, G Block, DDA Commercial Centre, Vikaspuri Branch, New Delhi, along with interest accrued thereon, is directed to be released to the appellant, and

(ii) out of the amount of ₹ 10 lakh deposited in the FDR bearing No. 922040088812875 dated 29 November 2022 at Axis Bank, Vikaspuri Branch, New Delhi,

(a) ₹ 6.5 lakhs along with interest accrued thereupon, be released to the legal heirs of the respondent namely Mrs. Manisha Khattar & Mr. Abhinav Khattar, and

(b) ₹3.5 lakhs along with interest accrued thereon be is directed to be released to the appellant.

5. The application is allowed in the aforesaid terms.
