Additional Public Prosecutor for the State.

2. The petitioner seeks bail in connection with Civil  
Lines PS Case No. 80 of 2024 dated 11-02-2024, instituted for  
the offence punishable under Sections 323,356, 379, 411 and  
307 of the Indian Penal Code.

3. Allegation against the petitioner is that one stolen  
mobile has been recovered from the possession of the petitioner.

4. Learned counsel for the petitioner submits that  
petitioner is innocent and he has been falsely implicated in this  
case. It is submitted that as a matter of fact, scuffle took place  
between the informant and petitioner while they are purchasing  
vegetables, due to which, informant lodged a false case against  
the petitioner of snatching his mobile. Charge sheet has been



submitted in this case. Lastly, it has been submitted that petitioner is in custody since 12-02-2024 having no criminal antecedents.

5. Learned APP has opposed the prayer for bail.

6. Having considered the facts and circumstances of the case and submissions of learned counsel for the parties, let the petitioner be released on bail upon furnishing bail bonds of Rs. 10,000/- (ten thousand) with two sureties of the like amount each to the satisfaction of the learned ACJM-1st, Gaya, in Civil Lines PS Case No.80 of 2024, subject to the following conditions:- (i) that the petitioner shall cooperate in the trial and shall be properly represented on each and every date fixed by the Court and on his absence on two consecutive dates without sufficient reason, his bail bond shall be cancelled by the Court below, (ii) that one of the bailors will be his own blood relation, preferably father, mother, brother, sister and or his wife, (iii) that the bailor shall also state on affidavit that he will inform the court concerned if the petitioner is made accused in any other case of similar nature after his release in the present case and thereafter the court below will be at liberty to initiate the proceeding for cancellation of bail on ground of misuse, and (iv) that if the petitioner tampers with the evidence or the witnesses,



in that case, the prosecution will be at liberty to move for  
cancellation of bail.

7. The application stands allowed.
