2. Learned counsel for the petitioners submits that the petitioners' case stands on similar footing as that of C.W.J.C. No. 2783 of 2021 along with other analogous cases, which was disposed of on 23.09.2022. Hence, the petitioners are entitled for the same benefit as granted to petitioners of C.W.J.C. No.2783 of 2021.
