Heard learned Senior counsel for the petitioner;
learned APP for the State and learned counsel for the informant.

2. The petitioner seeks bail in connection with
Kankarbagh P.S. Case No. 993 of 2023 registered for the
offence punishable under Sections 302 and 328/34 of the Indian
Penal Code.

3. As per the prosecution case, the petitioner and
others are accused of poisoning the deceased.

4. Learned Senior counsel for the petitioner submits
that the petitioner is the niece of the deceased and there is
general and omnibus allegation against her.

5. It has further been submitted by learned Senior
counsel for the petitioner that the deceased committed suicide
by consuming celphos and a false case has been filed against the
petitioner and others. It has also been submitted by learned
Senior counsels for the petitioner that there is a land dispute
between the parties. The petitioner is in custody since



25.10.2024.

6. Considering the fact that the petitioner is a women and there is general and omnibus allegation against her and also her period of custody, this application is allowed.

7. Let the petitioner, above named, be released on bail on furnishing bail bonds of Rs. 10,000/- (ten thousand) with two sureties of the like amount each to the satisfaction of the learned J.M.-1st Class, Patna/concerned Court in connection with Kankarbagh P.S. Case No. 993 of 2023, subject to the condition that the petitioner will co-operate in the trial.

8. Heard learned Senior counsel for the petitioner; learned APP for the State and learned counsel for the informant.

9. The petitioner seeks bail in connection with Kankarbagh P.S. Case No. 993 of 2023 registered for the offence punishable under Sections 302 and 328/34 of the Indian Penal Code.

10. The deceased is alleged to have been killed by poisoning her. The petitioner is the nephew of the deceased. The entire family has been made accused. In the FSL report, it has come that the deceased died because of poison i.e., celphos. The petitioner is in custody since 25.10.2024. It has also been



submitted by learned Senior counsels for the petitioner that there is a land dispute between the parties.

11. Considering the nature of allegation and the period of custody, this application is allowed.

12. Let the petitioner, above named, be released on bail on furnishing bail bonds of Rs. 10,000/- (ten thousand) with two sureties of the like amount each to the satisfaction of the learned J.M.-1st Class, Patna/ concerned Court in connection with Kankarbagh P.S. Case No. 993 of 2023, subject to the condition that the petitioner will co-operate in the trial.

Let the petitioner, above named, be released on bail on furnishing bail bonds of Rs. 10,000/- (ten thousand) with two sureties of the like amount each to the satisfaction of the learned C.J.M., Patna /concerned Court in connection with Kankarbagh P.S. Case No. 993 of 2023, subject to the condition that the petitioner will co-operate in the trial.
