application is for restoration of MJC No. 2390 of 2022 which



was dismissed due to non-compliance of the peremptory order dated 20.09.2024. He next submits that by order dated 20.09.2024 in MJC No. 2390 of 2022, this Court directed the petitioner to take fresh steps for issuance of notice upon O.P. No. 24, 26, 27 on their correct and present address within four weeks. The notices were filed within time, however, by mistake, the requisites for issuance of notices was filed in Original Civil Misc. No. 169 of 2020 instead of MJC No. 2390 of 2022.

Considering the aforesaid submission, let MJC No. 2390 of 2022 be restored to its original file subject to compliance of the order of this Court dated 20.09.2024 within four weeks.
