In the instant petition, petitioner has prayed for the following relief(s):

a) For quashing and setting aside the order dated 29.01.2025 passed in O.A. No. 050/00671/2019 by the Learned Central Administrative Tribunal, Patna Bench, Patna filed by the petitioner/applicant whereby the said Original



Application has been disposed of in terms of the order dated 21.02.2024 passed in O.A. No. 214/2022 along with other connected 49 Oas. Whereby those original applications have been dismissed by the learned Central Administrative Tribunal, Patna Bench, Patna as being devoid of merit.

b) For any other relief/reliefs which the Petitioner is entitled to.”

2. Learned counsels for the respective parties fairly submitted that the present matter is covered by co-ordinate Bench decision passed in C.W.J.C. No. 7341 of 2024 decided on 06.02.2025.
