3 06-03-2025 Heard learned counsel for the petitioners and learned counsel for the respondents.

2. Learned counsel for the petitioners submits that the case of the petitioners is squarely covered by the judgment passed by this Court in C.W.J.C. No.6689 of 2021 .

3. Considering the aforesaid facts, since the case of the petitioners stand on similar footings to that of the petitioners of C.W.J.C No.6689 of 2021, there is no requirement to keep



pending the present writ application.

4. Accordingly, petitioners are directed to file a detailed representation along with a copy of the order passed in C.W.J.C. No.6689 of 2021, before the respondent nos.3 within a period of four weeks and the respondent no.3 is well advised to consider the case of the petitioners and dispose of the representation of the petitioners after affording an opportunity of personal hearing or through their counsel and pass a reasoned and speaking order in accordance with law and in light of the order passed in C.W.J.C. No.6689 of 2021 within three months from the date of filing of such representation by the petitioners.

5. It is made clear that respondent no.3 shall be personally held responsible for non-compliance of this order.

6. With the aforesaid directions, this writ application stands disposed of.
