2. This is an appeal against acquittal filed in the year 2021. In the initial order dated 21.08.2021, the appellant was directed to file a supplementary affidavit annexing certified/xerox/true copy of the deposition of the witnesses examined and documents exhibited during trial. But, no such compliance was made. Subsequently, on the prayer made by



counsel for the appellant, further time was granted *vide* order dated 13.02.2023. Till date, the said order was not complied with. Moreover, the defects mentioned by the Stamp Reporter in Defect no.6(1) to 6(7) have not been removed.
