2. Learned counsel appearing for the petitioners fairly submits that the case of the petitioners was based on Annexure-1 which is the order dated 08.09.2011 passed in C.W.J.C. No. 8986 of 2011 and analogous cases. But the said order was challenged in LPA No. 1844 of 2011 and vide order dated 26.02.2014, the learned Division Bench of this Court has set aside the order dated 08.09.2011 passed in C.W.J.C. No. 8986 of 2011 and analogous cases (Annexure-1) and hence, learned counsel for the petitioners submits that the present writ application has become infructuous as no relief can be granted.
