2. Learned Counsel for the petitioners submits that the
matter pertains to non-formal education / instructors.

3. Learned Counsel for the State submits that the issue
in this matter has already been settled before the Supreme
Court, and that only those who moved before the Court prior to
26.02.2016 are entitled to relief.

4. In response, Counsel for the petitioners submits that
similarly situated persons have moved before the Hon'ble
Supreme Court of India, but the matter is still pending.

5. Since this matter is very old, therefore, the Court
deems it appropriate not to keep the matter pending.
Accordingly, the writ petition stands disposed off granting



liberty to the petitioners that, if any fresh cause of action arises before the petitioners then they shall be at liberty to move before the appropriate forum.
