2 29-04-2025 Heard the learned counsel for the petitioners and the learned counsel for the State.

2. This application has been filed for quashing of the FIR of Rajnagar P.S. Case No. 142 of 2023 dated 09.06.2023 in which petitioners and their entire family members have been made accused maliciously as no occurrence has taken place as



alleged in the FIR.

3. After some argument, learned counsel for the petitioners seeks permission to withdraw this application with liberty to raise all the grounds at an appropriate stage i.e., at the stage of cognizance or discharge.

4. Permission is accorded.

5. Accordingly, this application is dismissed as withdrawn.

6. The petitioners are given liberty to represent themselves before the Superintendent of Police, Madhubani by filing a representation.

7. If the Superintendent of Police, Madhubani finds substance in the representation of the petitioners then the case shall be investigated properly by the Police.
