counsel for the respondent-State.

2. The case of the petitioners is based on Annexure-1 which is the order dated 08.09.2011 passed in C.W.J.C. No. 8986 of 2011 and its analogous cases. The said order was challenged in L.P.A. No.1844 of 2011 and by order dated 26.02.2014, the learned Division Bench of this Court has set aside the order dated 08.09.2011 passed in C.W.J.C. No. 8986 of 2011 and analogous cases. Hence, the present writ application has become infructuous as no relief can be granted.

3. In the light of the above facts and circumstances, the present writ application is disposed of as having become infructuous because no relief can be granted to the petitioner on the basis of the Annexure-1 which already stands set aside by order dated 26.02.2014 passed in L.P.A. No.1844 of 2011.
