2. The present Cr. Misc. Application has been filed for cancellation of bail granted to the opposite party nos.2 to 7 by the learned District & Sessions Judge, Sheikhpura *vide* order dated 16.09.2020 passed in Sessions Trial No.40 of 2020 arising out of Ariyari P.S. Case No.14 of 2020.

After some argument, learned counsel for the petitioner submits that this case may be disposed of with direction to the learned Trial Court to expedite the disposal of the trial and the petitioner shall also co-operate before the learned Trial Court for early disposal of the trial in connection with Sessions Trial No.40 of 2020 arising out of Ariyari P.S.
