1. Heard the parties.

2. The petitioner has filed the present writ application
for a direction to the respondents to make transfer of the
petitioner in any other school as Teacher from Shri Ram Hari



Higher Secondary Education, Pabhera, Block Dhanarua, District Patna, on the ground that respondent no. 9 i.e., Headmaster of the School is threatening the petitioner of dire consequences.

3. Pursuant to the order dated 29.07.2025, District Education Officer, Patna, as well as S.H.O., Dhanarua, are present in person before this Court.
