Heard counsel for the petitioner, learned counsel for the State and learned counsel for the North Bihar Power Distribution Company Limited.

2. Learned counsel for the petitioner submits that the present writ petition has been filed seeking a direction to the respondent authorities to consider the petitioner's case for



promotion from the post of Superintending Electrical Engineer to Chief Electrical Engineer, along with all consequential benefits arising therefrom.

3. Learned counsel for the State submits that from the entire writ petition it transpires that the petitioner has never filed any representation.

4. In the aforesaid background, the petitioner is directed to file a representation before respondent No. 10, namely, the Managing Director, North Bihar Power Distribution Company Limited, along with a copy of this order, within 30 days from today.
