2. The present writ petition has been preferred for the

Authorities to open the lock from the
Holding No. 353 belonging to petitioner,
which has been locked by the Respondent
No.6 illegally and forcefully behind the back*



of petitioner, in compliance of an order passed in favour of private Respondent No.7 and 8 by Respondent No.5 with respect to Holding No. 352 and for grant of any other suitable relief/reliefs for which petitioner is found entitled in the eye of law.
