ORAL ORDER

2 19-09-2025 The present MJC is filed for modification of the order passed in CWJC No. 11802 of 2025 dated 21.08.2025.

2. It is pointed out by the learned counsel for the petitioners that inadvertently by mistake the addresses of the petitioner Nos. 1 & 3 have been wrongly typed as “Resident of village- Barandi, P.S.- Rahui, District- Nalanda. At present



residing at Chandra Bihar Colony P.S.-Rajiv Nagar, District-Patna” in place of “Nepali Nagar, 90 Feet Road, Near Kalimandir, P.S.-Rajeev Nagar, District-Patna” and the address of the petitioner No. 2 has wrongly been typed as “Resident of Jila Parshad Dakbanglow, Near D.D.
