Heard the parties.

2. In the present writ application, the petitioner has
prayed for the grant of following relief(s):-

*That the present application is for
issuance of a writ in the nature of writ of
mandamus directing the concerned respondent
authority to accept the joining of the petitioner
from the date he has given the same, in light of the
notification vide memo no. 748 dated 19.07.2024
issued by the Health Department, Government of
Bihar with all consequential benefits. And/or pass
such other order/orders as this Hon'ble Court may
think fit and proper in the facts and circumstance
of the case.*

3. During the course of argument, learned counsel for
the petitioner has drawn the attention of this Court to the letters
dated 30.07.2025 contained in Annexure-3 and letter dated



27.08.2025 contained in Annexure-4 to the writ application which have been addressed to Additional Secretary, Health Department, Bihar, Patna in which the petitioner has said that he has reported to the office of Civil Surgeon-cum-Chief Medical Officer, Khagaria for joining but the Civil Surgeon-cum-Chief Medical Officer, Gopalganj has not accepted the joining of the petitioner.

4. With the consent of parties, this writ application is being disposed of directing the Special Secretary, Department of Health, Government of Bihar to immediately, preferably within two weeks, issue a guideline in light of letters dated 30.07.2025 contained in Annexure-3 and letter dated 27.08.2025 contained in Annexure-4 to the writ application to the Civil Surgeon-cum-Chief Medical Officer, Khagaria and Civil Surgeon-cum-Chief Medical Officer, Khagaria shall act in accordance with the said guideline without wasting any further time.

5. With the aforesaid observation and direction, this writ application stands disposed of
