ORAL ORDER

3 18-02-2025 Heard learned counsel for the petitioner and learned
APP for the State. Perused the case diary.

2. The petitioner seeks bail in connection with
Muffasil P.S. Case No. 138 of 2024 G.R. No. 1222 of 2024
instituted for the offences under Sections 302/34 of the Indian
Penal Code.

3. Accusation against the accused persons including
petitioner is of commission of murder of the informant's brother.

4. Learned counsel for the petitioner submitted that the
petitioner has falsely been implicated in the present case.



Petitioner is not named in the F.I.R. The name of the petitioner transpired in this case during investigation on the basis of suspicion. No incriminating article has been recovered from the conscious possession of the petitioner. It has been submitted on behalf of the petitioner that the petitioner is in custody since 03.05.2024 and has no criminal antecedent.

5. Learned A.P.P. for the State has vehemently opposed the prayer for grant of bail to the petitioner. Learned APP further submitted that one Md. Azad has specifically stated the petitioner along with other co-accused assaulted the deceased by means of iron rod. Learned APP further submitted that as per paragraph no. 26 of the case diary, co-accused Md. Shahzad has confessed his guilt and also disclosed that this petitioner assaulted the deceased with iron rod. Learned APP has also submitted that the post-mortem report of the deceased also supports the case of the prosecution.

6. Having considered the rival submissions canvassed on behalf of the parties and the material available on record, it appears that the involvement of the petitioner in the commission of the murder of the deceased cannot be discarded and, therefore, this Court is not inclined to grant bail to the petitioner.



7. Accordingly, the prayer for grant of bail to the
petitioner is, hereby, rejected.
