2 17-11-2025 Heard learned counsel for the petitioner and learned
A.P.P. for the State.

2. The petitioner seeks bail in a case registered for
offence under Sections 140(1), 3(5) of the B.N.S., 2023 and
Section 27 of the Arms Act and later on, Sections 103(1) & 238
of the B.N.S., 2023 were added.

3. It is alleged that on the order of co-accused Sita
Devi and Rani Devi, co-accused Dabloo Yadav, Ticker Yadav,
Gaurav Yadav, Raushan Yadav, Parshuram Yadav and Uma
Yadav took out pistol from their waist and started indiscriminate
firing. All of them assaulted son of informant with butt of pistol,
due to which, he sustained several injuries and thereafter, all the
accused persons took him and fled towards Gyantol.
Subsequently, the dead-body of informant's son was found
covered in sand in the Diara area of Ganga river.



4. Learned counsel for the petitioner submits that as per F.I.R. itself, specific accusation of assault and kidnapping informant’s son is against other co-accused persons. So far as this petitioner is concerned, no overt act has been alleged against him. He is only alleged to be present at the place of occurrence. Petitioner is in custody since 06.06.2025. Chargesheet has been submitted.

5. Learned A.P.P. for the State opposes the prayer for bail.

6. Considering the aforesaid facts and circumstances as well as period of custody, let the above named petitioner be released on bail on furnishing bail-bond of Rs. 10,000/- (ten thousand) with two sureties of the like amount each to the satisfaction of learned A.C.J.M. - IV, Begusarai in connection with Sahebpur-kamal P.S. Case No. 149 of 2025.
