2. It is submitted by learned counsel for the petitioner that in compliance of the order dated 01.07.2019 passed by a Co-ordinate Bench of this Court in C.W.J.C. No. 8150/2011, a representation has been submitted by the petitioner before Respondent No. 9 i.e. Manager, Bettiah Estate, Bettiah vide Annexure 'P/26' dated 26.12.2023 which is still pending, therefore, it is prayed by learned counsel for the petitioner that



the petition may be disposed of directing Respondent No. 9 to consider and decide the same within a stipulated period fixed by this Court.
