2. The present application has been filed for modification in order dated 18.11.2024 passed in C.W.J.C. No.10290/2018.

3. Learned counsel for the petitioners submits that a detailed order has been passed on 18.11.2024 while disposing the C.W.J.C. No.10290/2018. Learned counsel for the



petitioners further submits that he has not communicated to the petitioners regarding the disposal of the said case within stipulated period. He further submits that stipulated time given to the petitioners for filing representation has already been expired.
