2 08-12-2025 Heard learned counsel for the petitioner and learned
A.P.P for the State.

2. The petitioner has preferred this application for grant of regular bail in connection with Turkauliya P.S. Case No. 252 of 2025 dated 31.05.2025 registered for the offences punishable u/ss 30(a) and 41(1) of the Bihar Prohibition and Excise Act and Section 25(1-B)(a) and 26 of the Arms Act.

3. As per the prosecution case, total 29.340 litres of illicit foreign liquor was recovered from the house of the co-accused, Raj Kumar Bhagat and one country-made katta was also recovered.

4. Learned counsel for the petitioner has submitted



that the petitioner is innocent and has falsely been implicated in this case. The petitioner has no concern with the alleged recovery. Nothing has been recovered from the conscious possession of the petitioner. The co-accused person has already been granted anticipatory bail by this court vide order dated 05.12.2025 passed in Cr. Misc. No. 60589/2025. The petitioner has two criminal antecedents in which he is on bail as stated in para 3 of the bail petition. The petitioner is in custody since 08.09.2025.

5. Learned A.P.P. for the State has vehemently opposed the bail petition of the petitioner.

6. Considering the aforesaid facts and circumstances of the case as well as the period of custody, the petitioner above-named, is directed to be enlarged on bail on furnishing bail-bond of Rs.20,000/- (Rupees Twenty Thousand) with two sureties of the like amount each to the satisfaction of learned Court concerned, Motihari, East Champaran in connection with Turkauliya P.S. Case No. 252 of 2025.

7. The application stands allowed.
