2 07-01-2025 The present writ petition has been filed seeking the following relief:-

"1. For issuance of an appropriate writ or writs, order or orders or direction or directions for commanding the respondents to remove the encroachment made over the public road/land bearing Khata No.1239, Khesra Nos. 3979, 3980 and 3981, which has been encroached by the private respondents and due to the said encroachment, the movement of vehicles has been closed as well as the petitioner along with other villagers are facing lot of trouble."
