2. Petitioners apprehend arrest in a case registered for the offences punishable under Sections 147, 148, 149, 341, 323, 337, 427, 353, 332, 504 of the Indian Penal Code, Sections 27 of Arms Act and Section 30(a) of the Bihar Prohibition & Excise Act.

3. As per prosecution case, on the alleged date and



time of occurrence, police apprehended two tractors loaded with illegal sand and it is alleged that these petitioners obstructed the police in discharging their duty, damaged the seized tractors and assaulted the police party.

4. Considering the fact that these petitioners obstructed the police party in discharging their duty and assaulted them, prayer for bail of the petitioners is refused.
