Affidavit-of-service filed on behalf of the
petitioner be kept with the record.

The petitioner, namely, Susmita Duley
would be appearing in the ensuing Madhyamik
Pariksha, 2025 as a *bona fide* student of Puinan
Girls' High School, Dadpur, District : Hooghly.

The grievance of the petitioner is that the
said Pariksha though is scheduled to be held on
and from February 10, 2025 but, in spite of
registration, she has not yet received the admit
card and is praying for issuance of the same.

It appears from the record that another
student of the said school, who is the namesake
of the petitioner, though was unsuccessful in the
Test examination but due to the mistake of the

school, has been enrolled with the Board for the said examination instead of the petitioner.

The petitioner, without any fault, is facing unnecessary anxiety before the first Board examination, as a respite for the students who have failed to enroll, the Board has decided to re-open the said designated online portal **and shall keep it open for the period from 6.00 P.M. today (February 06, 2025) till 2.00 P.M. tomorrow (February 07, 2025).**

The Headmistress of the said school, during the aforementioned period, shall upload all the particulars necessary for the enrollment of the student for the said examination and shall get the signature of the said student on the hardcopy of the enrollment application.

The Board shall keep its office open **on Saturday (February 08, 2025) and on Sunday (February 09, 2025)** respectively **from 11 A.M. till 2 P.M.**, within which time the said Headmistress, with all relevant documents, shall meet the Deputy Secretary(Examination) of the Board and upon payment of enrollment fees, stationary fees, late fees, late processing fees together with the costs of **Rs. 10,000/-(Rupees ten thousand only)**, the Board shall enroll the said student for the Madhyamik Pariksha, 2025 and shall issue the admit card.

The said Headmistress shall collect the said admit card on behalf of the student and shall deliver it to the residence of the said student.

The learned Counsel for the School submits that the admit card mistakenly issued to the said other student has already been returned to the regional office of the Board at Bardhaman. The Headmistress of the said school shall take forward steps for cancellation of enrollment of the said student.

WPA 2940 of 2025 is disposed of with the above terms.
