In Re: - An application for anticipatory bail under Section 482 of the Bharatiya Nagarik Suraksha Sanhita, 2023 in connection with **Purulia (S) Women** P.S. Case No.**32 of 2024** dated **05.08.2024** under Section **498A/323/307/34** of the Indian Penal Code and Sections 3/4 of the Dowry Prohibition Act.

Heard the learned counsels for the parties.

Perused the case diary.

Considering the materials available in the case diary and the alleged roles attributed to the present petitioners who are the brothers-in-law of the de-facto complainant, I do not think that custodial interrogation of the petitioners is required in this case and I am inclined to grant anticipatory bail to the petitioners.

In the event of arrest, the petitioners shall be released on bail upon furnishing a bond of Rs.10,000/- each with two sureties of like amount each, one of whom must be local, to the satisfaction of the Arresting Officer and also be subject to the conditions as laid down under Section 438(2) of the Code of Criminal Procedure, 1973 corresponding to Section 482(2) of the BNSS, 2023 and on further condition that the petitioners shall co-operate with investigation,

shall meet the I.O. once a fortnight till submission of report in final form and shall not threaten or intimidate witnesses.

The application for anticipatory bail is, thus, allowed.
