The Court : This is an appeal filed by the appellant/assessee under Section 260A of the Income Tax Act, 1961 (the Act), dated February 7, 2024 challenging the order passed by the Income Tax Appellate Tribunal Bench "A", Kolkata (Tribunal) in I.T.A. No. 475/Kol./2023, for the assessment year 2011-12.

Learned Advocate appearing for the appellant submits that he has received instruction from the appellant to withdraw this appeal as the appellant has opted for DTSV 2024, which is accepted by the Principal
