CIVIL APPLICATION NO. 3321 OF 2022 IN FA/425/2018 (Bringing Lrs.)

1. Mr. Adkine, learned counsel for the applicants would submit that during the pendency of the First Appeal, the applicant no.4 namely Kaduba Rama Ambhore died on 14.08.2021. Mr. Adkine, learned counsel would submit that right and interest of deceased Kaduba has devolved upon the present applicant nos.4a to 4f in the capacity of legal representatives of deceased Kaduba. Mr. Adkine, learned counsel would submit that due to trauma suffered by the death of Kaduba as also due to restrictions imposed in the Covid period, the application for bringing legal representatives on record could not be filed earlier and as such the delay of 80 days has been occurred in filing the present civil application. Mr. Adkine, learned counsel would submit that in order to secure the interest of applicant nos.4a to 4f, the application may be allowed and the applicants be permitted to incorporate the names of applicant nos.4a to 4f as legal representatives of deceased Kaduba.
2. The learned counsel for the respondents expresses no objection to allow the application.
3. In view of this, the Civil Application is allowed in terms of prayer clause "B".
4. The applicants are permitted to amend the title clause of the First

Appeal as the also the applications filed therein thereby incorporating the names of applicant nos.4a to 4f as legal representatives of deceased Kaduba Rama Ambhore.

5. Civil Application stands disposed of.

6. Place this matter on 19.11.2025 for further consideration. In the meantime, Mr. Adkine, learned counsel for the applicants in Civil Application No.9157 of 2018 would take appropriate instructions for bringing legal representatives of the deceased namely Sandu Maroti Ambhore. Mr. Adkine, learned counsel would approach to the Registry for clubbing all the matters as per the remark placed by the Registry on the board.
