4. The learned A.G.P. waives service for the respondents.

5. We dispose of the writ petition, directing respondent nos. 1 to 5 to consider and take a decision in accordance with law on the petitioner's representation/request dated 19.08.2024 and 21.08.2024 (**Exhibit 'S'**), albeit it is a notice issued through an advocate, by treating it as their representation.

6. The decision shall be taken as expeditiously as possible and in any case within twelve weeks.
