1. The learned counsel for the applicant submits that the name of the applicant is Ashruba Rangnath Bade, however, inadvertently in the judgment passed by the learned Reference Court name is mentioned as Ashruba Raghunath Bade. He points out that the learned Reference Court has vide order dated 17.02.2021 ordered correction of the name.

2. In that view of the matter, the applicant is permitted to correct the cause title in the appeal and all the Civil Applications by deleting the middle name as 'Raghunath' and by mentioning middle name as 'Rangnath'.
