. The respondent sole/land owner has moved the application seeking permission to withdraw the amount deposited by the appellant with this Court in compliance of order granting stay to execution of the impugned judgment and award passed by the learned Reference Court.

Having perused the judgment with the able assistance of learned Advocates, I find that interest of justice will be subserved by permitting the respondent/land owner to withdraw 75% of the amount deposited alongwith accrued interest, 50% on furnishing usual undertaking and 25% on furnishing solvent surety/security.
